Welcome:

Dr. Jeannie Davis welcomed everyone to the meeting.

Meeting Minutes:

The December 8, 2020 meeting minutes of the Linn, Benton, Lincoln Partners for Health were presented. **Shelagh Baird made a motion and Sheryl Casteen seconded the motion to approve the December 8, 2020 meeting minutes as presented. The motion was voted upon and unanimously approved.**

2021 Summit:

Ideas were discussed regarding the 2021 Summit.

- The 2021 summit will be a solutions summit and will be held virtually. We will provide different resources and solutions.
- **Dr. Jeannie Davis noted she contacted keynote speakers for the 2021 summit:**
 - Dr. Choo - \$7500 (60 mins)
 - OHSU, from Oregon
 - Dr. Tiffany Manuel - \$5000 – price for workshop
 - Health equity and affordable housing
 - Dr. Jim Rickards - \$3000
 - Healthcare innovations / entrepreneurship / telehealth

 - Dr. Kristina Hallet - \$8000
 - Resilience for First Responders / anti-burnout solutions
 - Dr. Joel Selanikio - \$17,500
 - Future of Health / WHO
 - Dr. Bonnie Clipper - \$5000
 - Practice and innovation for nurses/leading in turbulent times
- Other ideas for speakers/representation: Tara of OHA, Josh of Linn Co CASA
- Discussion on how to choose a keynote speaker:
 - Who is the most dynamic and who might be able to present in a breakout session in addition to the keynote?
 - Dr. Choo seems to be a bit expensive and cost may not include presenting in a breakout session
 - Dr. Choo and Dr. Manuel may be available to collaborate a breakout session together re: affordable housing

- Per JoAnn Miller, budget from SHS support is not available yet and unsure of the exact amount available for the Summit. This year there will not be federal grant dollars being contributed to the Summit.
- JoAnn Miller suggested inviting an oral health partner, possibly Linda Mann, to discuss health integration of the Dental Hygienist in medical centers and hospitals. DentaQuest is known to be a past and generous sponsor and could be a funding avenue if we decided to invite Linda Mann to present at a breakout session.
- *Dr. Jeannie Davis indicated she will be attending an upcoming advisory meeting for Linn County and plans discuss the 2021 Summit with the group to determine other topics/ speakers interested in presenting at the Summit. (EX: OHA, mental health services, etc.)*
- Discussion about inviting Linn Together due to their work with teens and substance prevention work. Linn Together is last active “Together” group in the state.
- Parenting education opportunities with Parenting Success Network, Pollywog Family, and Oregon Parenting Education Collaborative was suggested as another breakout session. Pollywog Family is a resource/referral group to assist families with children ages 0-6 yrs. old, OPEC is the states parenting education support collaborative and can discuss history, research, and supports for parenting education, and PSN (Sommer) can present current parenting education opportunities in Linn, Benton, and Lincoln Counties. It has been confirmed that these groups are available for the 2021 Summit.

Moving forward with 2021 Summit decision-making:

It was suggested that Jolynn begin building the outline of the 2021 Summit schedule to be able to start plugging in breakout sessions/speakers:

- It was decided that breakout sessions would be categorized by topic matter rather than by county to discuss what is happening in each community and how to expand or replicate in the communities who need more support.
- Shelagh Baird suggested prioritizing affordable housing as a topic at the 2021 Summit. It is an important initiative for Lincoln County and it was suggested by Krystal Boyechko to reach out to Sheila Stiley from NW Coastal Housing and/or Dev NW from Benton County.
- Other breakout sessions that were suggested:
 - **Nutrition**- importance and building parallels with health, the 5210 program, how business sector can promote, how to market nutrition and how to build successful programming from start to finish
 - **Live Longer Lebanon**- highlight their efforts around Blue Zone communities and their 5210 initiative and partnerships with schools, businesses, and healthcare
 - **Oregon Health Authority**- Population health
 - **UNITE US platform**- Closed loop referral system supported by IHN-CCO and is free for Community/non-profit organizations and offers resource/referral support for all ages/all people in which SHS is connected with. <https://uniteus.com/> Dr. Davis states that she will discuss with IHN about a presentation. Sommer is also able to reach out to Oregon’s Unite Us contact.
 - **Oregon State University**- interest in research projects from students to discuss the data they found, the history of the project, and how their project affects our communities.

Jolynn and Shelagh will reach out to their contacts to determine what projects would be applicable. Dr. Davis knows of a research project that could be applicable from students at COMP-NW.

- **Linn County CASA-** Dr. Davis states that she can contact the new Director of the Linn Co CASA, Josh to confirm his availability. There is interest around the future of community foster care in our region.- During the meeting availability was confirmed.
- **OHA-** it was discussed to invite OHA as a relevant speaker to discuss misinformation and promote unifying health messages for our area. Dr. Davis will contact Tara about availability.
- Moving forward with discussions of the keynote speakers it was agreed to eliminate from the list, Dr. Hallet and Dr. Clipper because the subject matter is not relevant to the audience of the 2021 Summit. Dr. Selanikio was also taken from the list due to the amount of the speaker's fee.
- The group will research the remaining list of possible keynote speakers on their own by exploring websites, videos, and Ted Talks to determine their preference (Dr. Choo, Dr. Manuel, or Dr. Rickards).

Announcements:

- **Dr. Davis-** announced that the medical students are back in person learning and in partnership with SHS helping with the drive through COVID19 testing. Western University has also purchased a building in town to provide PT and OT programming.
- **Julie Jacobs-** Moore Family Ctr is requesting funding from Bob Red Mill for nutrition and focus on rural and Indigenous areas with the hope of distributing food boxes with a whole grain available for each meal.

Next Meeting:

The next meeting of the Linn, Benton, Lincoln Partners for Health is scheduled for February 9, 2021.
