Welcome:

Dr. Jeannie Davis welcomed everyone to the meeting.

Meeting Minutes:

The February 9, 2021 meeting minutes of the Linn, Benton, Lincoln Partners for Health were presented. **Julie Jacobs made a motion and Sommer McLeish seconded to approve the February 9, 2021 meeting minutes as presented. The motion was unanimously approved.**

Oregon Health Authority Presentation:

Tara Weston and Ashley Thirstrup are available to present at our 2021 summit. They both shared information that could be shared at the summit. Tara Weston and Ashley Thirstrup work in Health Promotion and Chronic Disease Prevention and work with tobacco prevention. They also work with the 9 recognized federally tribes in Oregon.

- The different models they work with includes Policy Change Process Model, Systems Change Model, and Equity-Centered Policy Change Model.
- Policy Change Process Model - OHA developed 5-6 years ago in connection with the tobacco prevention program in counties.
 - a. Identify and frame problem
 - b. Engage community and stakeholders
 - c. Access readiness for policy change – Is there community support
 - d. Public education
 - e. Decision maker education
 - f. Draft policy and plan implementation
 - g. Adopt policy
 - h. Implement policy and support compliance
 - i. Evaluate impact
- Equity-Centered Policy Change Model- Newer not rolled out or tested yet. This model is translated in Spanish as well. In process of working with Coalition to develop video. Will roll out within the next few months and will provide a webinar. With this model:
 - a. Identify focus area
 - b. Build core team and process
 - c. Co-define and frame the problem
 - d. Access

- e. Co-create plans
- f. Implement
- g. Communicate
- h. Adapt
- i. Evaluate
- Equity-Centered Policy Change Model – At every step of the process, did you:
 - a. Think about who else needs to be there and recruit them
 - b. Authentically include community members, centering people of color – Ensure adequate time for building strong relationships
 - c. Use an equity and racial justice lens
 - d. Consider how to support transformative justice in the process
 - e. Clarify roles, responsibilities, and process
 - f. Define decision making process that is transparent, equity and community driven.
 - g. Ensure transparency
 - h. Identify and address barriers and incentives for community participation
 - i. Adapt your process and tools to make it relevant and accessible for different groups (i.e. plain language, translation, interpretation)
 - j. Value life experience
 - k. Create consistent messages
 - l. Surface, discuss, and address power imbalances
 - m. Address conflict, harm or failures, and unintended consequences
 - n. If community is not onboard, go back to the beginning
- Systems Change Model – Paths to system change – Less policy focused:
 - a. Understand the rationale/build the case
 - b. Map the system
 - c. Build partnerships and relationships
 - d. Decide what to accomplish together
 - e. Plan to make it happen
 - f. Implement the plan and learn from action
 - g. Monitor/evaluate/improve
- Question:
 - a. Are there organizations that use these models? At summit, would good to note what are results of using – Outcome of some programs from organizations using the different models.
 - A lot of organizations do use the Policy Change Model.
 - Will provide highlights.
 - The Equity-Centered Policy Change Model – Is brand new so no outcomes yet.
 - **Carly Castaneda** – There is also a national model – Community Anti-Drug Coalitions of America. They represent a lot of community coalitions and involve individuals from key sectors.

2021 Summit:

- It might be a good idea to reference our Mission, but we could do this in the description of the summit. Members present liked the title, ***“2021 Partners for Health Solutions Summit (blurb later about what this means...mending, stronger together, etc.)”***
- ***At the next meeting it was agreed to firm up the title for the summit and discuss a possible keynote speaker.***
 - a. What topic would we like the keynote speaker to speak on – Public health type topic? See all as a global topic as social determinants of health or health equity – Whole big picture – All services offered for the community. It would be good to have the keynote do a story type presentation.
 - b. OSU has some different alumni speakers or PSU or even Oregon Health Authority.
 - c. Maybe even look at some type of information related to healing/mending – What are things going to look like down the road – Resiliency – Effects after COVID.
- Jolynn Meza Wynkoop noted that she reached out to someone from the Oregon Pain Summit. They use Zoom for their yearly conference. Samaritan Health Services does have Webinar Go. It costs approximately \$250 for Zoom Pro. It was suggested to call Zoom and check on options.
- We have \$3,500 in the budget for our summit.
- ***Both JoAnn Miller and Dr. Jeannie Davis will look at additional keynote speakers.***
