Welcome:

Dr. Jeannie Davis welcomed everyone to the meeting.

Meeting Minutes:

The March 9, 2021 meeting minutes of the Linn, Benton, Lincoln Partners for Health were presented. Jolynn Meza Wynkoop made a motion and Krystal Boyechko seconded to approve the March 9, 2021 meeting minutes as presented. The motion was unanimously approved.

County Health Rankings:

JoAnn Miller reported on the County Health Rankings.

- The Robert Wood Johnson Foundation County Health Rankings for 2010-2021 was reviewed. The County Health Rankings and Roadmaps is in connection with the University of Wisconsin Population Health Institute School of Medicine and Public Health. Counties are ranked based on Health Outcomes How healthy is a county and Health Factors What influences the health of the county. Health Outcomes and Health Factors for Benton, Lincoln, and Linn Counties Health for 2021 were noted.
 - a. Benton County Health Outcomes 1 and Health Factors 1.
 - b. Lincoln County Health Outcomes 27 and Health Factors 26.
 - c. Linn County Health Outcomes 18 and Health Factors 11.
- This year, 34 counties were ranked. There were no ratings this year for Gilliam and Wheeler Counties.
- Last year the report had additional narrative and more information on the communities. This year just the measures and data is listed.
- People are encouraged to go on the website <u>www.countyhealthrankings.org</u> for additional information.
- There has been concern expressed with Lincoln County consistently being in the bottom portion of the rankings and what we can do to improve.
 - a. Dr. Lesley Ogden is focusing on homelessness and the unhoused. A meeting is scheduled with Lincoln County staff to look at ways to improve the Health Outcomes and Health Factors for Lincoln County.
 - b. **Aimee Snyder** The County Integration Network and Affordable Housing group meeting regularly. There are seven municipals of jurisdiction in Lincoln County. We know there are barriers that exist with City Council, etc. How do we bring things together to make larger changes? Shelagh Baird also attends some meetings throughout Lincoln County.

Aimee Snyder will let JoAnn Miller know on the dates and times of the meetings.

2021 Summit:

Ideas were discussed regarding the 2021 Summit.

- Jolynn Meza Wynkoop organized the top 3 areas of interest noted from the last Summit (Access to mental health/behavioral health, affordable housing, and youth health and wellbeing) into a table noting category, organization, speaker topic, contact, PFH member reaching out, status, and notes.
- At the last meeting, it was agreed that the name for the summit would be, "2021 Partners for Health Solutions Summit" (blurb later about what this means...mending, stronger together, etc.)

- Tracks will include: Access to behavioral and mental health, and oral health services, youth health and wellbeing, and affordable housing.
- We could choose those organizations within the workshops and come up with a rough draft of talking points for participants.
- DevNW Krystal Boyechko reached out and hasn't heard back yet. She also has some emails out to Unity Shelter.
- Jolynn Meza Wynkoop noted that she hasn't heard from Kassi Coleman with the Boys and Girls Club of Albany. John Andersen is the Director for the club. *JoAnn Miller will send contact information to Jolynn Meza Wynkoop*.
- Boys and Girls Club Corvallis Helen Higgins Suggested to partner with Samaritan health Services on pediatric and mental health services. She feels comfortable talking about dental services they provide. It was noted that the Boys and Girls Club Corvallis is in a partnership with Benton County Health on dental.

The Samaritan Pediatric clinic and mental health partners provides some funding for adults, but this is not through the Boys and Girls Club. Helen Higgins noted she is happy to plan something and is just waiting for the next steps.

- Themes could follow through with all the workshops or we could look at different topics.
- It was suggested to look at who is confirmed and give them talking points to get started.
- Keep breaks in and 30-minute lunch break to help with retention and focus.
- The question was asked about interactions within the workshops. Learning helps with engagement. Suggest creating ways to engage your audience. *Julie Jacobs noted she will come up with a list and send to Shelley Hazelton for distribution*.
- It was noted to keep the keynote speaker at 45 minutes with 15 minutes for questions and answers.
- Also, keeping a break for 15 minutes after the keynote speaker, would be good.
- It was agreed to keep the sessions 45 minutes to an hour in length.
- It will be good to advertise topic areas.
- CTSI can address both youth mental health and the health clinic.
- The Olalla Center has LGBTQ+ affirming counselors and the hope is that they can cover this area as well.
- We haven't heard back yet from Kelley Story for the STARS program. JoAnn Miller noted that she would follow up with her.
- Housing/affordable housing/homelessness We don't have as many organizations presenting on this topic.
- Organizations will speak on their program(s) and what has worked and share success stories.
- Can we look at evidence-based housing initiatives Zoning/advocacy? It was noted this is also an expertise of DevNW. Krystal Boyechko will be following up with them. JoAnn Miller noted that the contact person for DevNW is Rebecca Weinsteiger and she would reach out to her.
- Common-Wealth Development They helped develop the affordable housing unit north of Newport. *Shelagh Baird will also reach out to them.*
- Sommer McLeish noted that she will be having a meeting with Lola Jones with Samaritan House in Lincoln County tomorrow. *She can also reach out to Family Promise as well.*
- There is the HOPE Coalition (Benton County) or the Housing First Initiative. *Krystal Boyechko will be following up with Unity Shelter and HOPE*.
- It was noted that Lebanon homeless outreach Had an old ambulance donated for their outreach and they also have a mobile shower.
- Jeff Blackford and Amelia with Communities Helping Addicts Negotiate Change Effectively (C.H.A.N.C.E.) and 2nd C.H.A.N.C.E. Homelessness Waiting to hear back.
- It was noted that Michael Davidson in Sweet Home is opening a shelter It may be a spin off from Albany Helping Hands. Received a grant to do a renovation. *Dr. Jeannie Davis noted she can reach out to Dick Knowles regarding the Sweet Home shelter.*
- Jolynn Meza Wynkoop will be contacting Heide Lambert with Lincoln County CASA.
- Lincoln County School based health center and mental health Jessica Hubbard would be a good contact for the school-based health center and Shelby Houston would be a good contact for mental health. *Jolynn Meza Wynkoop will follow up*.
- Live Longer Lebanon/5210 campaign/Community Health-Nutrition Deb Fell-Carlson was asked to present. Deb Fell-Carlson noted she was honored to be asked to present. This was listed as "maybe."

- Dr. Jeannie Davis shared information about a possible keynote speaker, Dr. Jim Polo, who is the Executive Medical Director of Regence Blue Cross Blue Shield of Oregon. He was with Cambia Health Solutions in Portland for 3 years. He has not been approached yet to see if he would be available to present.
 - a. It was noted that Cambria Health was part of the process when Lebanon was looking at becoming a Blue Zone and it was not favorable. It was noted that his name does not come up.
 - b. It was the consensus of those present for Dr. Jeannie Davis to reach out to Dr. Jim Pollo to see if he would be available to present.
 - c. JoAnn Miller noted we will need to review the budget. We don't have the grant to match this year. *She will follow up on the budget.*
 - d. Other possible speakers to explore OHSU, OSU, Portland State, etc. JoAnn Miller will check into additional speakers. She noted that Dr. Bruce Goldberg used to be the Director of the Oregon Health Authority. He is a medical doctor and is on the Oregon Community Foundation Board. He would be an excellent speaker. JoAnn Miller agreed to check to see if he would be available to present as the keynote speaker. It was further agreed that JoAnn Miller would check with Dr. Bruce Goldberg first before contacting Dr. Jim Pollo.

Announcements:

Announcements were shared.

- Deb Fell-Carlson noted that Samaritan Lebanon Community Hospital donated \$2,500 toward the Faith Community Nursing Course. They are working on getting a match. The course will be offered October 18-19, 2021 8:00 a.m. 5:00 p.m., November 1-2, 2021 from 8:00 a.m. 5:00 a.m., and November 15-16, 2021 from 8:00 a.m. 2:00 p.m. There are currently 6 nurses on the waiting list to take the program. COMP-NW medical students will help present.
- JoAnn Miller reported that they just had the 15th Annual African American Youth Leadership (AAYL) conference. There was approximately 110 students that attended the virtual event. There were youth from Linn, Benton, Lincoln, and Lane Counties and some kids also from Bend and Redmond in attendance. The event was from 9:30 a.m. 12:00 p.m.
- Dr. Jeannie Davis noted that they received a stem grant through LBCC for the Comp-NW Health Career Ladder program to do virtual learning.
