- **Luis Acosta** – How many interpreters are needed?
 - a. **Dr. Jeannie Davis** – Last time we had 3 and may have had 4 before that. Having 3 interpreters available would be helpful.
- **Holly Terlson** – Chris Eilers will do the workshop session on Health Impacts of Loneliness. She is helping Dr. Helen Kao get ready for her presentation so won't be available to do a workshop.
- **Sommer McLeish** – Pollywog would like a resource table. They may need their own table rather than share with Parent Success Network.
- **Holly Terlson** – She connected Dr. Helen Kao with Dr. Carolyn Aldwin.
- The Save the Date flyer was distributed and was available in English and Spanish. Summit flyers in English and Spanish will go out along with the Eventbrite registration page. *Jolynn Meza Wynkoop is working on the Eventbrite registration page. Sommer McLeish indicated she would be following up with Jolynn Meza Wynkoop on the actual summit flyer.*
- **Sommer McLeish** – *Will check with Samaritan Health Services Marketing to see if information on the flyer can be posted. Sommer McLeish agreed to check with Jolynn Meza Wynkoop to see if information can be posted on the Coast to Cascades Community Wellness Network website.*
- **Deb Fell-Carlson** – Can add information to the Live Longer Lebanon Facebook page and the Faith Community Nursing Facebook page.
- Does Samaritan Health Services have a Facebook page?
 - a. **Sommer McLeish** – Yes, Samaritan Health Services does have a Facebook page. *Agreed to check to see if she can get this on the Samaritan Health Services Facebook page.*

- Resource tables:
 - a. *Sommer McLeish will contact Olalla Center, Linn Together, 211, Community Services Consortium, Legal Aid, and Connect Oregon to see if they want a resource table at our summit.*
 - b. *Dr. Jeannie Davis will contact Linn-Benton Equity Alliance, Linn County Public Health, and Linn County Public Health to see if they want a resource table at our summit.*
 - c. *JoAnn Miller will contact someone at Samaritan Treatment and Recovery Services (STARS) to see if they would like to have a resource table for the event.*
 - d. Faith Community Health Network – Deb Fell Carlson – Has been confirmed.
 - e. Rx Namaste – Britny Chandler – Has been confirmed.
 - f. Parent Success Network – Has been confirmed. May add Pollywog with their table or Pollywog may need their own table.
 - g. Suggest adding a Legal Aid resource table. Can have information for undocumented families. There has also been discussion about adding public charge to the Access Services workshop.
 - h. **Shelagh Baird** - Depending upon how many resource tables we have and how many we can have we could think about adding a table on the tri-county media campaign on stigma reduction and substance use disorder (SUD). It was noted that JoAnn Miller will be seeing if STARS would like a table. It's possible we could combine the media campaign/stigma reduction/SUD with their table.
 - i. **Dr. Jeannie Davis** – Will decide on July 14, 2022, how many resource tables we can have and whether they will be downstairs or upstairs.
 - j. *It was agreed to refer those individuals that will have resource tables to Shelley Hazelton who will then follow up with them on details related to their table.*
- Raffle – Will there be a raffle. *It was agreed that the raffle would be vendor specific.* The vendor/representative at each of the resource tables can decide whether they want to hand out any freebies or have a raffle basket for their table.
- **Dr. Jeannie Davis** – LBCC does want to market the Chinook Center for this event.
- Additional items of discussion:
 - a. Do we want a host for each room?
 - b. Do we want a timekeeper?
 - c. Last year, Jolynn Meza Wynkoop monitored the chat box. We would need a host or someone for each room to monitor chat.
 - d. **Shelagh Baird** – How many people would we need? It was suggested that we have at least 3 people as hosts for the workshop sessions.
 - e. *Shelley Hazelton will do registration. She will most likely need someone to help.*
 - f. Suggested hosts included – Dr. Jeannie Davis, Sommer McLeish, Jolynn Meza Wynkoop, Michelle Means and Joanna Kubes.
 - g. *Sommer McLeish agreed to host the Access Services workshop with MyChart and Luis Acosta and monitor chat for those workshops.* She has I-pads that will be available for use.
 - h. *Dr. Jeannie Davis – Can host and monitor chat for the Youth Wellness and Resilience workshops.*
 - i. *Shelagh Baird – Will attend the summit virtually, but she could also help monitor chat in workshops or with the opening/closing speakers.*
 - j. Do we want to have a practice session with all the speakers?

- k. PowerPoints – At the last summit, Jolynn Meza Wynkoop had put together a main PowerPoint. *Sommer McLeish agreed to check to see what Jolynn Meza Wynkoop is available to provide related to the summit.*
- l. Public Health is doing a Regional Health Assessment and Samaritan Health Services is doing a Community Health Needs Assessment for each of its five hospitals. Will data be available that could be shared?
 - **Shelagh Baird** – She doesn't think they will be ready to share data by August. *She will reach out to Sara Hartstein with Benton County and will reach out to Lincoln County, but she is almost sure they won't have any data available to present yet.*

Next Meeting:

The next general meeting of Linn, Benton, Lincoln Partners for Health is scheduled for August 9, 2022, at 1:00 p.m.

There was discussion about having another meeting prior to August 9, 2022, to work at finalize all the details for the summit. *It was agreed to have a meeting on August 2, 2022, at 1:00 p.m. Shelley Hazelton will send out a calendar notice.*
