**Meeting Summary**

**Participants:** Shelagh Baird, Jeannie Davis, Ed.D., Terri Facknell, Julie Jacobs, Joanna Kubes, Sommer McLeish, JoAnn Miller, Jolynn Meza Wynkoop, Aimee Snyder, and Shelley Hazelton

**Welcome:**

Dr. Jeannie Davis welcomed everyone to the meeting.

**Meeting Minutes:**

The June 8, 2021 meeting minutes of the Linn, Benton, Lincoln Partners for Health were presented. **Shelagh Baird made a motion and Julie Jacobs seconded to approve the June 8, 2021 meeting minutes as presented. The motion was unanimously approved.**

**Culinary Health Education Fitness (C.H.E.F.) Strategic Plan Updates:**

At the May and June meeting, we discussed the C.H.E.F. Strategic Plan and Linn, Benton, and Lincoln Counties Partners for Health areas of focus for 2022.

**Resource Guides:**

- At the June meeting we discussed gathering information from partners and building on existing networks. This was also part of a goal listed in the Strategic Plan related to building on existing networks and community partnerships to leverage resources and increase community impact. We also suggested putting together a list of summit resources. *Jolynn Meza Wynkoop noted that she will work on this after the 2021 Partners for Health Solutions Summit.*
- Do we want to put this on our website? It was agreed that this would be included on our website. We do need to review our website to make sure it is user friendly for those who may view. *Shelagh Baird is working in connection with Ian Rollins, Samaritan Health Services (SHS) Marketing on the website.*
- A live document through Google Docs was also suggested.

**Focus for 2022:**

- Previous suggestions for areas of focus included addressing issues around isolation, diversity-equity-inclusion, public health/community health, nutrition, obesity, Substance Use Disorder (SUD) and looking at a website with real time data for services and bed capacity. There was also discussion on continuing with cooking classes and PA and looking at the social determinants of health and the impact such as chronic conditions and meeting the needs of low-income individuals, people of color, and the Indigenous population.
- A possible focus for the next Summit might be talking about isolation and addressing issues and providing resources. We might want to also tie in the social determinants of health and look at equity and diversity.
  - a. Are we wanting to select a topic or several topics from our Solutions Summit and find someone that specializes in that and take a deeper dive for next year's Summit?

- **JoAnn Miller** – Each year we give out Social Accountability grants for Benton, Lincoln, and Linn Counties. There will be discussions with leadership for 2022 to look at funding major projects for 3 years that address one of the social determinants of health, needs, goals and priorities of SHS and demonstrate an impact on equity, diversity, and inclusion. We would still fund local projects for one-year in each county for 2022. There will be discussion on where should SHS target their interest. Some top areas noted in the Samaritan Hospitals’ Community Health Needs Assessments included:
  - a. Housing/homelessness
  - b. Mental health/behavioral health
  - c. SUD prevention, treatment, and recovery
  - d. Child abuse and/or neglect
  - e. Food insecurity and poverty

SHS has focused in the past 10 years on chronic conditions and obesity, homelessness, youth initiatives, tobacco cessation, transportation, dental, oral health, teen pregnancy, and childcare.
- We had an OSU Intern do an environmental assessment for Benton and Linn Counties and presented information at the 2019 summit and there was the food retailer assessment for Lincoln County that was also presented.
- Members were asked for additional ideas for focus for 2022. The following ideas were noted.
  - a. Housing is an issue – Healthy, stable housing. How do we change the housing environment and system policy changes and for those doing a pathway to recovery? How do we work with jurisdictions to create policy to make this happened? This trickles down to the basic needs of food, etc.
    - Healthy community models – What is the design of the community and what makes a healthy community? Housing, transportation, systems of health all make a healthy community.
    - Trauma related housing/trauma informed, especially since the fires, and how important housing is. Look at bringing together those that manage properties.
    - As we move forward in the public health arena, we can see how important housing and the social determinants of health interact together. We need affordable and low-income housing.
    - Housing and the community and how important the community is and having connections.
  - b. Community cohesion and connectiveness impacts health – Front porches are now garages, so people don’t communicate as much with their neighbors.
  - c. Isolation from COVID-19 and mental health – Drug/alcohol use may have increased due to isolation.
  - d. **Terri Facknell** – OSU did project on effects of COVID and isolation. We do have experts in this area.

**2021 Summit:**

The 2021 Solutions Summit was discussed.

- m. **Other LGBTQIA2S+ Contacts:**

  - Earlean Wilson Huey has also reached out to DCE, but she hasn’t heard back from them.
  - Jolynn Meza Wynkoop noted that she has reached out to Out N’ About Support Group, but she hasn’t received a response back from them.
  - There is Pride Circle, which is in Klamath Falls.
  - There is an LGBTQIA2S+ mentor program in Coos County.

- JoAnn Miller noted that she followed up with Marty Cahill and Julie Manning regarding their part in the event.
- The Center for Health Education (all conference rooms) is available on the day of the event for staff to go and set up and run the event.
- ***Members were asked to let JoAnn Miller know if they will attend in person at the Center for Health Education in Newport so we can plan to have lunch delivered.***
- We will use the Zoom platform for the event and SHS will provide the Zoom account.
- ***Jolynn Meza Wynkoop agreed to be the main person in charge of the event.***
- ***Joanna Kubes agreed to host Workshops 1, 5, and 10.***
- The Save the Date notice has gone out.
- ***JoAnn Miller agreed to email the keynote speaker – Max Williams to follow up with him regarding the summit.***
- Registration for the event will go live on July 20, 2021.
- Do we want attendees to be able to decide what workshops they want to attend or in Zoom while we are live – Have them choose at that time? Zoom has the capability to preload breakout session names and people can select. It was agreed to let attendees choose the workshops when registering for the event.
- Do we want to limit the number of attendees in each workshop? ***Jolynn Meza Wynkoop will explore setting the limit in Eventbrite on the workshops.***
- Will need to have practice Zoom sessions prior to the event. Will include interpreters in some sessions.
- All interpreters are on board and available for the event.
- Eventbrite is set for 400 attendees.
- Ian Rollins with SHS Marketing Department has put out a press release on the summit.

### **Announcements/Additional Business:**

Additional business and announcements were noted.

- A new Health and Human Services Director has been hired for Lincoln County Health and Human Services. Her name is Jayne Romero. JoAnn Miller noted that she met with them to discuss the Coast to Cascades Community Wellness Network.
- **Aimee Snyder:**
  - a. The funding has been renewed for two years for the tobacco prevention work.
  - b. They receive referrals from medical providers and connect with UNITE US.
  - c. Funding has also been renewed for two years for the alcohol and drug prevention program. They are promoting alcohol/drug free spaces.
  - d. New staff has been hired.
  - e. Working on systems change with primary care.
  - f. Hepatitis C – Received funding from IHN-CCO to work with primary care to do Hepatitis C treatment.
- **JoAnn Miller:**
  - a. We received Measure 110 funding. We initially weren't funded, but there was additional funding given out and we were selected.
  - b. We will receive \$760,000 for a six-month period.
  - c. Samaritan Lebanon Community Hospital applied on behalf of a network of 10 community-based and governmental organizations to support those individuals with Substance Use Disorder (SUD) in rural and urban areas of Benton, Lincoln, and Linn Counties. The 10 network partners include:
    - Samaritan Lebanon Community Hospital

- Communities Helping Addicts Negotiate Change Effectively (C.H.A.N.C.E.)
  - Community Services Consortium (CSC)
  - Family Tree Relief Nursery
  - Lincoln County Health and Human Services
  - Lincoln County Sheriff's Office
  - Linn County Alcohol and Drug Program
  - Milestones Family Recovery
  - Reconnections Alcohol and Drug Treatment, Inc.
  - Samaritan Treatment and Recovery Services (STARS)
- d. We will also partner with the Confederated Tribes of Siletz Indians and Benton County Health Services on the next round of funding.
- The network partners target adults, youth, and families who are uninsured, underinsured, low-income, unhoused, racially, and ethnically diverse, LGBTQIA+, pregnant women, and veterans across our tri-county region.
  - As part of Senate Bill 755, each county in Oregon will be required to have a Behavioral Health Resource Network.
  - **Terri Facknell:**
    - a. The Corvallis Community Center has a tri-county Renew Active Program for Benton, Lincoln, and Linn Counties. There's walk with youth. They work with UNITE US. Is part of prescription for health and patients can be referred to the program.
    - b. Medicare Wellness Program – Can work out for free for 18 and over – Exercise and swimming for free.
  - **Dr. Jeannie Davis:**
    - a. The medical students are required to do 30 hours of community service in 2 years – Community Impact Project - Starting their second year. Students connect to organizations to provide community service. They can do projects in all three counties (Benton, Lincoln, and Linn).
    - b. Interprofessional Education Program – Involves LBCC and Physical Therapy program and COMP-NW. Looking for community members to tell stories to the medical students, Physical Therapy students, and LBCC Nursing students.

**Next Meeting:**

The next meeting of Linn, Benton, Lincoln Partners for Health is scheduled for August 10, 2021.

There will be a practice run through for the Summit the week of July 26<sup>th</sup>. There was also discussion for a possible practice run through after the August meeting.
