#### Welcome:

Dr. Jeannie Davis welcomed everyone to the meeting.

### **Meeting Minutes:**

The July 13, 2021 meeting minutes of the Linn, Benton, Lincoln Partners for Health were presented. Joanna Kubes made a motion and Jolynn Meza Wynkoop seconded to approve the July 13, 2021 meeting minutes as presented. The motion was unanimously approved.

# **Strategic Plan Updates:**

# **Resource Guides:**

Resource Guides – Part of goal listed in the Culinary Health Education and Fitness (C.H.E.F.) Strategic Plan related to building on existing networks and community partnerships to leverage resources and increase community impact. *Jolynn Meza Wynkoop was going to work on after the 2021 Solutions Summit.* Will add to our website. There are so many good contacts with presenters at the summit and available resources.

#### Focus for 2022:

The document – Strategic Plan Focus areas for 2022 was reviewed. Listed were suggestions from the last few months of discussion on the topic. Discussion followed.

- Do we want to look at the list and focus on a topic or topics for 2022 at our October meeting?
  - a. Committee members were in favor of this.
- Addition suggested areas of focus included:
  - a. COVID-19 is at the top of the public health list. We could look at the effects of COVID and everything that surrounds it such as people's wellness, things they've done to overcome issues, and their resilience, etc.
  - b. **Terri Fackrell** OSU did a project on the impacts of COVID-19 with Carolyn Aldwin, Ph.D., Jo Ann Leonard Director of the Center for Health Aging She will be presenting a free lecture on February 10, 2022 at 12:30 p.m. called, "Recovery and Resilience During COVID." Terri Fackrell also noted that she and Heidi Igarashi, Ph.D., Courtesy Faculty Member in the OSU School of Social and Behavioral Sciences in the College of Public Health and Human Services will be presenting a free lecture on November 18, 2021 at 12:30 p.m. on "Strategies for Re-Entering Your Social World." Dr. Heidi Igarashi did a similar project as Dr. Carolyn Aldwin.
  - c. Dr. Carolyn Aldwin might be a good speaker for our next summit.

d. The Corvallis Fire Department is working on the impact of those with chronic conditions that call for emergency support. The "impact of chronic conditions" might be another focus to look at in 2022.

#### **2021 Summit:**

The group finalized details for the upcoming summit.

- Work continues with last minute details for the 2021 Solutions Summit scheduled for August 20, 2021. A practice session is scheduled with the workshop hosts/staff for Friday, August 13, 2021. This is the second practice session.
- Attendees will be able to choose the workshops they would like to participate in on the day of the event so they won't need to be pre-assigned ahead of time.
- During the upcoming practice session, we will practice sharing some presenter slides to make sure everything works correctly. There is also a You-Tube video that one presenter will be showing.
- There have been 36 representatives/organizations that would like to present at the workshops. There have been 26 that have responded back on their bio's and what their needs are. *Jolynn Meza Wynkoop continues to reach out to all presenters*.
- There will be 4 interpreters available the day of the event.
- Working at finalizing the script for Julie Manning and the main summit PowerPoint.
- Documents will be created for each host of the workshops and they will each have the bios for each presenter in that workshop so they can introduce the speakers.
- The Zoom link for the event will be sent out a day before the event as well as the day of the event.
- We need to update the evaluation/survey from last year. *JoAnn Miller will look for the evaluation from last year*. Could have Julie Manning talk about filling out the evaluation during her final remarks. The evaluation may have been done via Survey Monkey. *Dr. Jeannie Davis can update for this year's summit.*
- There have been 98 attendees signed up to date.
- It was suggested to advertise through the Well Informed the Samaritan Health Services (SHS) employee newsletter.
- Deb Fell-Carlson had indicated previously that she would share with the Live Longer Lebanon group and Facebook page.
- JoAnn Miller will send information to Ian Rollins in SHS Marketing to post.
- Britny Chandler had indicated previously that she would share out on the Oral Health Facebook page.
- Dr. Jeannie Davis noted that she shared information with the Linn County Health Advisory Committee.
- Jolynn Meza Wynkoop indicated she would send out the flyer to different Coalition members such as the behavioral health groups and the Community Harm Reduction Mentors and Allies group.
- The group expressed thanks to Jolynn Meza Wynkoop for all her amazing work with the summit.

#### **Announcements/Additional Busines:**

Additional business and announcements were made.

• Madison Yock – Youth Initiative - Youth Focus Wellness – Through Live Longer Lebanon – Waiting for someone to co-lead with her. The goals for the initiative is to create youth focused efforts to improve health and wellness in Lebanon youth.

- They will create fun and exciting opportunities for kids in the community to socialize and participate in organized activities. Live Longer Lebanon proposed a youth driven and adult guided group.
- **JoAnn Miller** She had suggested at the Live Longer Lebanon group to look at the youth and the policy piece to empower youth to advocate for youth-focused programs and policy at the local and state levels.
- The Lebanon Downtown Association is looking for youth input to make downtown Lebanon more youth friendly.
- Madison Yock Quite a while back there was a Mayor's Youth Council consisting of about 6-8 sophomore, junior, and seniors to be the voice of students. After the group graduated, no one came back and the group disbanded. Madison Yock noted that she is helping facilitate in Sweet Home with the City of Sweet Home Youth leadership as part of community feedback they receive on city parks in Sweet Home.
- **JoAnn Miller** Received a new HRSA Rural Communities Opioid Response Program Implementation Grant. The grant is for \$1 million for 3 years to reduce morbidity and mortality related to substance use disorder (SUD) including opioid use disorder (OUD) in East Linn County. The project will serve youth, pregnant woman/child-bearing woman, and adults. The program starts September 1, 2021. We will advertise for a 1.0 FTE Project Director-Data Coordinator. The grant is through Samaritan Lebanon Community Hospital in partnership with Family Tree Relief Nursery, Samaritan Treatment and Recovery Services (STARS), Communities Helping Addicts Negotiate Change Effectively (C.H.A.N.C.E.), Linn County Alcohol and Drug, and Community Health Centers of Benton and Linn Counties.
- **JoAnn Miller** We are releasing our Social Accountability grants for 2022 and will have a grantee information meeting on August 26, 2021 at 10:00 a.m. The grants support non-profit, 501(c)(3) organizations in Benton, Lincoln, and Linn Counties. The Request for Proposal will be released on August 20, 2021 and grant applications are due by October 1, 2021 at 4:00 p.m. In 2022, it will be the last year for 1-year grants. We will move toward 3-5-year grants to encourage collaboration and making a larger impact in the community. Funding goals and priorities include:

- **Dr. Jeannie Davis** COMP-NW Open They have a new 2025 class of medical students. They are COVID testing and looking at community outreach. The medical students must do community service-community impact projects, which is 30 hours within 2 years. The goal is to have these as rollable projects that students can bring forward. Student orientation will occur this week. It was suggested that the medical students connect with the Lebanon Downtown Association and the alternative schools to mentor at risk youth.
- Lillie Manvel Was invited by Deb Fell-Carlson. She is the Executive Director for Upstream Public Health and Coalition Coordinator for Healthy Active Oregon Coalition. Healthy Active Oregon is planning to start building a coalition in Linn County to generate enthusiasm about voluntary policies around children's restaurant menus and health retail space.
- **JoAnn Miller** Will notify us if there are changes in SHS' policy for facility use.
