## Linn, Benton, Lincoln Partners for Health (Partners for Health) Summit Discussion and Finalization Virtual through Microsoft Teams 1:00 p.m. – 1:40 p.m. August 2, 2022 Meeting Summary

## Welcome:

Dr. Jeannie Davis welcomed everyone to the meeting.

## 2022 Summit:

Discussion focused on the 2022 Summit.

- Summit date: August 19, 2022.
- Location: Lin-Benton Community College (LBCC) Chinook Hall.
- **Sommer McLeish** Had someone express their concern with the title of the summit since we aren't really living in a post-pandemic environment.
  - a. **Dr. Jeannie Davis** When we first picked the title we thought we would be out of the pandemic.
  - b. **Sommer McLeish** Maybe we can say, "Building Resilience Wellbeing & Mental Health Resources for a Post-Pandemic Environment."
  - c. Everyone agreed to change the title to, "Building Resilience Wellbeing & Mental Health Resources for a Post-Pandemic Environment. Jolynn Meza Wynkoop will update the flyers and registration page.
- **Catering** We may be able to use OSU Catering with Tina Dodge Vera being part of our committee. *Shelley Hazelton will need to confirm for sure with JoAnn Miller*.
- **Dr. Jeannie Davis** Dr. Carolyn Aldwin is the keynote speaker. She has indicated that she is not for sure at this time if she will be attending in person or virtual.
- **Dr. Jeannie Davis** We have an issue with Workshop A Youth Wellness and Resilience. Dr. Amanda Emmert thought she was going to help with the workshop, but she didn't realize she would be the main presenter. *JoAnn Miller will be checking on some possible speakers and Dr. Jeannie Davis is also reaching out to some residents.* 
  - a. Is there another topic to put in that place?
  - b. **Dr. Jeannie Davis** What other organizations work with youth?
  - c. **Shelagh Baird** What about school-based programs that work with at risk youth? There is the Job Opportunities for Youth (JOY) Project in the Lincoln County Schools that helps students in homeless living situations.
  - d. **Sommer McLeish** That's a good idea with the school district, but not sure anyone is back yet from the summer vacation.
  - e. **Dr. Jeannie Davis** There might be something through the Linn Benton Education Center or Linn Benton Lincoln Education Services District – *Dr. Jeannie Davis will reach out.*

- f. **Shelagh Baird** There is Project Bravery specific to LGBTQ+. They will be at the summit with a Resource Table.
- g. Jolynn Meza Wynkoop At the last Community Harm Reduction Mentors and Allies meeting Blue Valentine suggested reaching out to Mara Sargent at Benton County Public Health. *Thought JoAnn Miller was going to reach out to her.*
- h. Jolynn Meza Wynkoop Linn County Alcohol and Drug has a Life Skills program. Maybe they could be part of a panel discussion. Justin Thomas would be the contact. Jolynn Meza Wynkoop noted she could check with him. Not sure he would do a whole presentation. Was thinking more of a panel discussion.
- i. Do we want a panel discussion? It was noted that JoAnn Miller was checking with some providers. Might be simpler to have one presenter rather than a panel. It might be good to go with a physician for the workshop.
- j. Jolynn Meza Wynkoop Can also reach out to staff at Samaritan Health Services that do the Continuing Medical Education (CME) programs to see if they have a contact for youth health and wellness.
- Will Marty Cahill provide the Welcome and Opening Remarks *Will need to confirm with JoAnn Miller?*
- Jolynn Meza Wynkoop Registration is up and active. So far no one has indicated Spanish interpretation.
- **Dr. Jeannie Davis** They have mandated again at COMP-NW for wearing N95 masks. Not sure about Linn-Benton Community College (LBCC). *Dr. Jeannie Davis noted she will check on LBCC requirements.* They may be preferred but not required.
- Workshop B Health Impacts of Loneliness and Social Isolation Chris Eilers will be there and in person.
- Workshop C Access Services MyChart Heather Kenagy. I-pads will be available for the workshop. Sommer McLeish will follow up to make sure everything is set up for this. Part of Workshop C is public charge. Sommer McLeish is following up with someone from Legal Aid for covering this part of the workshop.
- **Dr. Jeannie Davis** May be putting lunch in a conference room. Resource tables will be in the lobby.
- LBCC will be sending all Zoom links for the workshops. Dr. Jeannie Davis noted that we used the LBCC Chinook Hall the other day with a meeting at the facility. The main room had one microphone for the presenter and the presenter walked around the room so those attending virtual could hear. IT will be available the day of the event to assist if needed.
- Luis Acosta Acosta Services staff is fully vaccinated and they will be tested before starting the program. He will have 3 interpreters available.
- The building will be open at 8:00 a.m. the day of the event. Registration begins at 8:30 a.m. LBCC will provide all the tables for those having a resource table at the event.
- Jolynn Meza Wynkoop Registration and Advertising:
  - a. At this time, we have 22 people that have indicated they will be attending the summit in person. There are 23 people who have indicated they will attend the summit virtually.
  - b. Are there any additional places to advertise?
  - c. **Dr. Jeannie Davis** Will advertise with OSU Public Health Department and have them share out.

- d. It was suggested to provide outreach on the summit to the Hispanic Advisory Committee.
- e. Will it be shared at Samaritan Health Services in the "Well Informed" and did anyone reach out to the Marketing Department at Samaritan Health Services to post on the website?
- f. **Sommer McLeish** Has contacted Administration at Samaritan North Lincoln Hospital to add as part of the Daily Brief.
- g. **Dr. Jeannie Davis** Will be sending flyers out to the Health Advisory Boards and faculty and staff at COMP-NW and the Chamber of Commerce.
- h. **Joanna Kubes** There is a new organization geared to the Latino community in North Lincoln County that is interested in disaster preparedness and resiliency. They may be interested in the summit. *She will send them information.*
- **Evaluation** The last couple of summits we have done an online evaluation. *Jolynn Meza Wynkoop agreed to do the online evaluation.*
- **Presentations** Will request copies of the presentations from presenters and ask presenters to provide a virtual introduction.
- All conference/classrooms at LBCC are Zoom compatible and a tech will be available the day of the event so we should be fine and shouldn't need to practice prior to the event.
- **Shelagh Baird** Will attend remotely. What interface with tech or what does she need to do? Is there someone LBCC to talk to help facilitate the session.
