Welcome:

JoAnn Miller welcomed everyone to the meeting and led introductions.

Meeting Minutes:

The July 5, 2023, meeting minutes of Linn, Benton, Lincoln Partners for Health were presented. Sommer McLeish made amotion and Luis Acosta seconded the motion to approve the July 5, 2023, meeting minutes as presented. The motion was voted upon and unanimously approved.

Health Resources and Services Administration (HRSA) Grant - Addressing Violence in Rural Oregon Communities:

Sommer McLeish reported on the Addressing Violence in Rural Oregon Communities Grant.

- Noted that she has been working with the grant now for a few weeks.
- The Addressing Violence in Rural Oregon Communities Project will focus on child abuse, domestic violence, and human trafficking in Lincoln and east Linn Counties.
- Coordinating with the different partners on the grant including ABC House, Acosta Services, Center Against Rape and Domestic Violence (CARDV), Sarah's Place and the Linn-Benton Anti-trafficking Coalition Elizabeth Bauermeister is the Coordinator for this group.
- CARDV in collaboration with Sarah's Place is developing evidence-based age-appropriate curriculum on Sexual Violence Prevention in Sexual Health Education for middle school and high school students in rural east Linn County.
- ABC House will provide counseling services once a week in Sweet Home and Lebanon.
- Met with Luis Acosta to build a focus group concentrating on Latinx, Mam-speaking, and other marginalized community members in Lincoln County.
- Met with Elizabeth Bauermeister to discuss a Violence Prevention Summit. We will have one in east Linn County and another one in Lincoln County. Will look at the January – June 2024 for the summit for east Linn County.
- We will be educating team members and provide education for direct service providers and health care workers.
- Will host in-person Strangulation Institute training for medical professionals working at Emergency Departments and Medical Facilities in the Region.
- Different partners will present each month to Linn, Benton, Lincoln Partners for Health Elizabeth Bauermeister will present in September on human Trafficking and Labor Trafficking. There will be no presentation in October. In November ABC House will present. Luis Acosta will present in December and CARDV and Sarah's Place will present in January.

• JoAnn Miller:

- a. This will give us opportunities to hear from organizations that are part of the grant.
- b. We are one of the first communities in the nation to receive a federal grant to look at violence.
- c. We hope to make an impact and reduce the numbers around child abuse, domestic violence, and human trafficking with this grant.
- d. She and Sommer will be attending a conference the end of August for the grant in Atlanta, Georgia.
- e. We will provide regular updates to the Coast to Cascades Community Wellness Network (CCCWN) and the CCCWN Steering Committee.

2023 Summit:

Discussion focused on the 2023 Summit. A spreadsheet for the summit was noted.

- **Time** 9:00 a.m. 3:30 p.m. Check in and registration to start at 8:30 a.m.
- **Welcome** Marty Cahill will provide a welcome the day of the event.
- Closing Dr. Lesley Ogden will provide a brief closing at the end of the summit.
- Current Workshops (All speakers are confirmed):

 - b. Mental Wellbeing Kari Hart, MSW, LCSW, Samaritan Health Services (SHS)
 - c. Youth Services River Aaland, Ophelia's Place
- Food Confirmed with Ultralife. They will bring food around 12:15 p.m. JoAnn Miller and/or Shelley Hazelton will pick up breakfast items at Costco/or another store.
- **Keynote Speaker** Dr. Kelly Gonzalez Waiting on final confirmation from her.
- Since we have not received final confirmation from the keynote speaker, do we have a backup keynote speaker. Would it be possible for Dr. Jeannie Davis to be a backup speaker?
 - a. Dr. Jeannie Davis "Yes," she could be a backup speaker if needed. She could discuss community outreach, the medical school, cooking classes, etc.
- The Confederated Tribes of Siletz Indians will provide a land acknowledgement.
- We are waiting to hear if the Confederated Tribes of Siletz Indians youth drumming circle is available to provide lunch entertainment. *Jolynn Meza Wynkoop noted she would follow up on the youth drumming circle*.
- **Resource Tables -** Will be upstairs. These will be 5-foot tables. Those interested in resource tables include:

- Cooking Demonstration Beatriz Botello-Salgado and Jennifer Pettit will provide the cooking demonstration and incorporate Food Hero recipes. Kathy Brier had noted having a couple people in the kitchen and the rest of the attendees in the larger conference space during the demonstration would work best. If you get too many people in the kitchen it will block the camera.

Someone would need to operate the camera if they wanted to project on the big screen. Jolynn Meza Wynkoop noted she could go ahead of time and check everything out if needed.

- JoAnn Miller We can look at going the day before the summit on August 24, 2023, to the Center for Health Education and test out all the rooms and bring up the different presentations to make sure everything works correctly. Shelley Hazelton will check with Kathy Brier to see if some people can come over the afternoon of August 24th to test everything out at around 2:00 p.m.
- Panel Discussion Elizabeth Bauermeister (will talk about human trafficking), Shannon Snair (Linn County Health Services talk about suicide prevention/mental health first aid), and Dr. Robert Fallows (Samaritan Medical Group talk about behavioral health/mental health) will all be part of the panel. Can Dr. Jeannie Davis facilitate? Do we want questions in advance to discuss in case we do not get questions from the audience?
 - a. Dr. Jeannie Davis agreed to facilitate the panel.
 - b. "Yes," we do want questions ahead of time for the panel. The panelist could provide a brief introduction of themselves, provide an overview of their services, and answer posed questions.
 - c. Questions for consideration could include:
 - What does a whole approach to health mean to you?
 - When we talk about diversity, equity, and inclusion, what do you see as a service and how are you reaching marginalized populations.
 - What are solutions you see as working to reach youth more effectively in our communities?
 - ➤ What is missing in our communities for youth population and marginalized groups?
- We are limited to 72 people for the main conference rooms. To date we have 48 people registered.
- **JoAnn Miller** Did a big push with Samaritan Health Services (SHS) to post information on the summit on the SHS Insider and our external website.
- Not sure how we assist people that may have barriers to getting to the conference. We have not heard that anyone has any barriers.
- **Jolynn Meza Wynkoop** Working on a summit booklet to hand out. Is modeling after previous summits. Will ask the Document Center to print. The booklet will have an agenda, a section on meeting the presenters with pictures and workshop descriptions, list the members of Linn, Benton, Lincoln Partners for Health, and a notes page. Will solicit feedback once finished. Will also send a copy to Luis Acosta to translate into Spanish. Do we want one program with a combined program in English and Spanish or two separate programs.
 - a. It was agreed to have one program.
- **Sommer McLeish** Can we have the evaluation as an insert in the booklet?
 - a. **Jolynn Meza Wynkoop** Will have a paper option for the evaluation and QR code option as well and can insert the paper option in the booklet.
- So far, we have had one person interested in interpretative services.
- **Luis Acosta** Will have two interpreters at the summit. One will include his daughter who will interpret from Spanish to English during his workshop.
- Will ask Luis Acosta to translate anything we have printed for the summit into Spanish.
- It was suggested at the beginning of each workshop to have the hosts for each of the rooms (Jolynn Meza Wynkoop, Sommer McLeish, and Dr. Jeannie Dais) read the bio for each workshop speaker.

- **Jolynn Meza Wynkoop** Do we want to bring the CCCWN marketing materials, like the sign, pens, etc. to the summit?
 - a. **JoAnn Miller** Yes.
- **Beatriz Botello-Salgado** Could we send the recipes to attendees Is a way to advertise? Will have three Food Hero recipes.
 - a. **Jolynn Meza Wynkoop** Could include the recipes in the program.
 - b. **Beatriz Botello-Salgado** "Yes," that would be a great option.
 - c. **JoAnn Miller** Did we need to shop for the supplies for the cooking demonstration or will Samaritan Health Services be invoiced.
 - d. **Beatriz Botello-Salgado** She will shop for the food for the cooking demonstration and will invoice us.
- **Jolynn Meza Wynkoop** Will be asking presenters to email her a copy of their presentations and will email copies to the hosts for each room.
